#### Westlaw and Lexis

Westlaw and Lexis are two pay-for-use online legal research services that provide primary federal, state, foreign and international materials, and secondary resources such as legal newspapers and law reviews, and legal information. The coverage of dates for each source varies. The cost of the online service varies per user and database. Some academic and law libraries offer free access to Westlaw or Lexis to library patrons. The UA Library online catalog offers free Lexis from the "Lexis Academic" database.

Of the two services, Westlaw has the more extensive database on Indian law in its "Native American Law" grouping. Included are: treaties (1787-1883), Presidential proclamations (1879-date), Executive Orders (1871- date), Solicitor General opinions (1917-1974), IBIA decisions (1970-date), federal cases and codes, Oklahoma Tribal Court reports (1979-date), selected texts, American Indian Law Review articles, and a directory of Native American lawyers. A recently added database is West's American Tribal Law Reporter of headnotes of selected tribal, U.S. Courts of Appeals, and U.S. Supreme Court decisions. "Native American Law" is not offered in free Westlaw.

#### Versus Law

TribalCourts.com (VersusLaw) was developed in conjunction with the National American Indian Court Judges Association (NAICJA). The company contracts with tribes to provide electronic access to Native American opinions. Access is free and unlimited to participating tribes, but a subscription for non-participating tribes and other researchers is very reasonable at under \$10 per month per professional.
